10 **ORDER**

11 WHEREAS, it appearing to the Court that four vacancies exist on the Client
12 Protection Fund Commission due to the expiration of the terms of Jeffrey L. Baker,
13 Leigh Ann Chavez, and Matthew C. Sanchez, and the resignation of John M.
14 Caraway, and the Court being desirous of filling said vacancies, Chief Justice
15 Michael E. Vigil, Justice Barbara J. Vigil, Justice C. Shannon Bacon, and Justice
16 David K. Thomson concurring;

17 NOW, THEREFORE, IT IS ORDERED that Jeffrey L. Baker is reappointed
18 to the Client Protection Fund Commission for a three-year term, said term to expire
19 December 31, 2023;

20 IT IS FURTHER ORDERED that Tanya Noonan Herring is appointed to the
21 Client Protection Fund Commission for a three-year term, said term to expire
22 December 31, 2023;

1 IT IS FURTHER ORDERED that Hon. Linda M. Vanzi is appointed to the
2 Client Protection Fund Commission to fulfill the unexpired term of John M.
3 Caraway, said term to expire December 31, 2021;

4 IT IS FURTHER ORDERED that Hon. Linda M. Vanzi is eligible for
5 reappointment to the Client Protection Fund Commission to serve two full three-
6 year terms upon expiration of her current term;

7 IT IS FURTHER ORDERED that James T. Reist shall serve as Chair,
8 Hon. Linda Vanzi shall serve as Vice-Chair, and Jeffrey L. Baker shall serve as
9 Secretary/Treasurer of the Client Protection Fund Commission;


10 IT IS FURTHER ORDERED that Benjamin I. Sherman, as Secretary-
